- Instantly send a document via DocuSign no more saving PDFs, creating emails, and attaching files. Just click 'Start ApprovelT flow' from your document (e.g., a sales quote), customize recipients, email text, and attachments if needed, and you're ready to go!
- Simplified digital signatures: customers, suppliers, and applicants can easily e-sign documents, eliminating manual signatures.
- Automated process: once signed, any workflow can be initiated.
- When the recipient has received and opened the email, you can see this in Business Central.
- Secure storage: signed documents are stored digitally with customer signatures in Business Central or Azure Storage.

- Sales documents
- Purchase documents
- Service documents
- Job documents and contracts

It is also possible to use ApproveIT on non-standard BC documents. The app is designed to work with custom or app solutions in combination with ApproveIT 365.

ApproveIT 365 is available in English, Dutch, French, and German.



Steps to simplify your sales workflow:

- 1. Create a Sales Quote or Sales Order in Business Central.
- 2. Use ApproveIT 365 to promote the document to DocuSign for secure digital approval.
- Your customer/prospect receives the document via email, reviews it, and signs it electronically.
- 4. Once signed, ApproveIT 365 automatically converts the Sales Quote into a signed order, initiating the appropriate processes in Business Central, such as starting production, order fulfillment, or extending services.
